PLEASE READ NEW VENDOR RULES**

Please set up Friday between 10:00 a.m. and 6:00 p.m. or no later than 9:00 a.m. Saturday. Vendors will park in the designated school parking area. Absolutely no vehicles allowed on show premises. Parking permit will be sent to you when your complete app is received and fee paid.

\*An emergency Paramedic and Fire lane must be open. All Dogs must be leashed.

All vendors are responsible for cleaning space daily into a trash bag and placed into trash cans.

\*All vendors must email photos of all items for sale and booth setup and accurately include your legible email address and phone number on app and email to [caindmkt@gmail.com](mailto:caindmkt@gmail.com)

All vendors must not sell sensitive items, pipestone sacred pipes, ceremonial items or artifacts.

All items must be made by artist or Rep, not manufactured, not imported; no plastic items.

Otherwise, you must remove these items when a monitor tells you they are inappropriate.

Artists should have Certificate of Authenticity available for customers/collectors. All vendors must include California Resale Number on your initial application or it will be rejected.

No alcohol or recreational drugs allowed anywhere on premises. This is School property.

No photography, video recording, copying or documentary or sale without Reyna's permission.

Vendors provide own setup/security. Sponsors are not responsible for lost, strayed, stolen items, or any natural or manmade act, nor liable for any bodily injury or property damage.

Unsigned or incomplete applications will not be accepted. No refunds after the Vendor is accepted by the jury selection committee. App & Fee will be returned to those ineligible.
